CLEANSING NOTICE UNDER SECTION 708A OF THE CORPORATIONS ACT

This notice is given by Allegiance Coal Limited ACN 149 490 353 (ASX code: AHQ) (**Allegiance**) under section 708A(5)(e) of the Corporations Act 2001 (Cth) (Corporations Act). As outlined in Allegiance's announcement of 29 March 2018 (**Announcement**), Allegiance completed a placement of 78,390,000 fully paid ordinary shares (**Placement Shares**) to sophisticated and institutional investors at an issue price of \$0.05 per share.

In accordance with section 708A(6) of the Act, Allegiance confirms that:

1. The Placement Shares were issued without disclosure to investors under Part 6D.2 of the Corporations Act.
