Gullewa Ltd : Loan of \$659,000 which may be satisfied by the issue and allotment of shares in Allegiance Coal Ltd at a price of \$0.025 per share (subject to any share reconstruction and shareholders' approval) or by repayment in cash, subject to Gullewa's agreement. The loan was interest free until 4 August 2019, after which interest accrues daily and is capitalised monthly, at a rate of BBSW + 4%, on any unpaid balance. The loan must be repaid in full, whether in cash or by the issue and allotment of shares in accordance with the agreement reached between the parties, by 4 August 2021.

Promissory notes : Unsecured promissory notes with a face value totalling \$992,503 repayable on 31 March 2020, bearing an implied interest rate of 12% pa.
