<p>Answer: Yes</p> <p>In common with resource exploration and development companies, the Company expects that it will continue to have negative operating cash flows until such time as it is able to bring an operating mine into production.</p>	

8.8.2 Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?

Answer: Yes.

In July 2020, the Company announced it has secured up to \$8 million of funding by way of a secured convertible note issued to Mercer Street Global Opportunity Fund LLC, a New York based investment fund; \$662,000 to be drawn immediately with \$1,338,000 to be drawn following shareholder approval; and with further amounts to be drawn at the discretion of the parties subject to any required shareholder approval.

The Company requires additional funding to meet its business objectives and intends to secure such funding from sources including but not limited to:

- Further equity capital raisings;
- The potential farm-out of participating interests in the Company's tenements and rights; and / or
- Other financing arrangements.

The Company currently has capacity to place, without shareholder approval 57,542,648 ordinary shares in accordance with ASX Listing Rule 7.1A.

The Company's officers are in regular contact with Allegiance's major shareholders and other potential financiers and the Directors believe on reasonable grounds that the financing steps outlined above will be successful.

8.8.3 Does the entity expect to be able to continue its operations and to meet its business objectives and, if so, on what basis?

Answer: Yes

Having carefully assessed the likelihood of securing additional funding (as set out in the answer to question 2 above), and the Company's ability to effectively manage its expenditures and cash flows from operations, the Directors believe that the Company will be able to continue its operations and meet its business objectives for the foreseeable future.
