The loan of \$659,000 may be satisfied by the issue and allotment of shares in Allegiance Coal Ltd at a price of \$0.025 per share (subject to any share reconstruction and shareholders' approval) or by repayment in cash, subject to Gullewa's agreement. The loan will be interest free until 4 August 2019, after which interest will accrue daily and be capitalised monthly, at a rate of BBSW + 4%, on any unpaid balance. The loan must be repaid in full, whether in cash or by the issue and allotment of shares in accordance with the agreement reached between the parties, by 4 August 2021.
